SIEC: SERAP demands transparency from governors

The Socio-Economic Rights and Accountability Project (SERAP) has called on Nigeria's 36 state governors to disclose comprehensive details about the State Independent Electoral Commissions (SIECs) in their jurisdictions to enhance transparency and accountability. In an official statement on Sunday, SERAP urged the governors to reveal information about the chairpersons and members of the SIECs, including their qualifications, political affiliations, and appointment mechanisms. Additionally, SERAP emphasized the need for detailed reports on the outcomes of local government elections since 1999 and the associated voters' registers.



Alhaji Yusuf Mamman Dantalle, the national chairman of the Inter Party Advisory Council (IPAC), has called for the establishment of an independent body responsible for appointing the chairman, national commissioners, and resident electoral commissioners of the Independent National Electoral Commission (INEC). Dantalle proposed that this shift of power from the President to a neutral entity, subject to Senate confirmation, would ensure impartiality, asserting that it's inappropriate for the President, who is involved in elections, to appoint its umpire.

'It's not with us' — N'Assembly disowns 'bill seeking return of Nigeria to regional government'

The National Assembly has dissociated itself from a purported draft bill seeking to return Nigeria to a regional system of government, which was reportedly drafted by an individual named Akin Fapohunda, who is not a member of the assembly. Senate spokesperson Yemi Adaramodu clarified that no such bill is currently before the National Assembly.
