## FCT Area Council Chairmen's tenure ends 2026, says INEC

The Chairman of the Independent National Electoral Commission (INEC), Prof. Mahmood Yakubu, has announced that the tenure of elected Chairmen and Councilors in the six Area Councils in



the Federal Capital Territory will end in June 2026. He made this clarification during a meeting with the leadership of the Inter-Party Advisory Council in Abuja on Friday, following numerous inquiries from stakeholders regarding the tenure based on the Electoral Act 2010, which initially provided for a three-year term.

# Court nullifies Edo PDP Governorship Primary

A Federal High Court in Abuja invalidated the Peoples Democratic Party (PDP) primary election that had selected Asue Ighodalo as its candidate for the upcoming governorship election in Edo State. Justice Inyang Ekwo ruled that the PDP's primary, held on February 22, did not comply with the Electoral Act 2022 and the party's constitution.



Ahead of the Edo Governorship election, Yiaga Africa has deployed 24

#WatchingtheVote long-term observers (LTOs) across the 18 local government areas in Edo state. The LTOs who participated in a two-day intensive training, in Benin, Edo state were tasked to ensure accurate observation of pre-election activities which includes violence-monitoring in their respective LGAs. The preelection observation will enable a data-driven assessment of the electoral process to promote electoral integrity. In addition, the team led by Cynthia Mbamalu, the Director of Programs, met with the Commissioner of Police and INEC to discuss the preparations for the election. The #WatchingTheVote deployment for the Edo governorship election is supported by the United States Agency for International Development (USAID).



### **NNPP's NEC Extends Yusuf's Suspension By Six Months**

The National Executive Council (NEC) of the New Nigeria People's Party (NNPP) has extended the suspension of Governor Abba Yusuf of Kano



State to December 2024. A joint communique signed by Umar Jibrin and Johnson Omolara stated that Governor Yusuf, who is the only NNPP-elected governor, was initially suspended in February for alleged insubordination. Additionally, the NEC confirmed the expulsion of Rabiu Musa Kwankwaso, the party's Presidential Candidate in the 2023 general elections.
