

Senate introduces bill to establish electoral commission for LGs

The Senate has introduced a bill to establish the Local Government Independent Electoral Commission. Sponsored by Sani Musa, the senator representing Niger East, the bill had its first reading on Thursday. This proposed legislation comes about a week after the Supreme Court mandated that the federal government directly allocate funds to local government councils from the federation account.

INEC Accredits 134 Election Observer Groups For Edo, Ondo Guber Polls

The Independent National Electoral Commission (INEC) has accredited 134 election observer groups for the upcoming Edo and Ondo offseason governorship elections scheduled for September 21 and November 16, 2024. According to a statement released by INEC national commissioner and chairman of the Information and Voter Education Committee, Sam Olumekun, 124 of these groups are domestic, while 10 are international.

Barely a day after a Federal Court in Abuja reinstated Philip Shaibu as the Deputy Governor of Edo State, an undisclosed number of people were injured on Thursday when armed thugs fired shots at the convoy of the All Progressives Congress (APC) governorship candidate, Senator Monday Okpebholo, and Shaibu. The attack occurred around 2 p.m. as the group was leaving Benin Airport upon arrival from Abuja.


Incomplete registration: INEC invites 246 new applicants from Edo, Ondo for validation

The Independent National Electoral Commission (INEC) has invited 246 new applicants—82 from Edo and 164 from Ondo state—to provide complete data to ensure their eligibility to vote in the

upcoming governorship elections in both states. In a statement on Thursday, Sam Olumekun, the National Commissioner and Chairman of the Information and Voter Education Committee, announced that a cleanup of the register using the Automated Biometric Identification System (ABIS) revealed that the biometric details of these applicants did not meet the threshold for seamless accreditation.

A three-man panel of the appellate court, in a unanimous judgment, dismissed an appeal seeking to overturn the Tribunal's decision.

Court upholds Uzodinma's election as Imo gov

The Court of Appeal in Abuja has dismissed the appeal filed by the Peoples Democratic Party (PDP) and its governorship candidate, Samuel Anyanwu, challenging the Imo State tribunal's decision that

affirmed Hope Uzodinma as the authentic governor of the state. The court ruled that the appeal lacked merit, having resolved all issues against the appellants. Similarly, the appellate court also dismissed the appeals by the Labour Party and its candidate, Achonu Nneji, as well as the Allied Peoples Movement, for also lacking merit.

Bill seeking sixyear single term for president, govs scales first reading

The House of Representatives on Wednesday passed the first reading of a bill proposing an amendment to the 1999 constitution to establish a single six-year term for the offices of the President, State Governors, and Local Government Areas Chairmen. The bill was sponsored by Ikenga Ugochinyere, the representative for Ideato North/Ideato South Federal Constituency in Imo State, along with other lawmakers.
