INEC Solicits National Peace Committee's Support For Peaceful Elections In Edo, Ondo

The Independent National Electoral Commission (INEC) has urged the National Peace Committee (NPC) to back its call for stakeholders to ensure peaceful elections in Edo and Ondo states. INEC Chairman, Prof. Mahmood Yakubu, made the appeal on Friday, August 16, during a briefing to the NPC on the Commission's preparations for the upcoming governorship elections, scheduled to take place in 35 days and 91 days, respectively.


Just in: Anambra to conduct LG election September 28

Ogun LG polls: ADC kicks against imposition of N250,000 fee on candidates

The African Democratic Congress (ADC) in Ogun State has criticized the N250,000 nomination fee imposed by the Ogun State **Independent Electoral Commission** (OGISIEC) for the upcoming local government election. During a stakeholder meeting on Thursday, OGISIEC Chairman Babatunde Osibodu announced that chairmanship candidates must pay N250,000, while male councillorship candidates are required to pay N150,000 and female candidates N100,000. The election is scheduled for November 16, 2024.


RSIEC Denies Postponing October 5 Rivers Local Govt Elections

The Rivers State Independent Electoral Commission (RSIEC) has denied reports of a postponement of the local government elections scheduled for October 5, 2024. In a statement issued on Tuesday, RSIEC Chairman Justice Adulphus Enebeli

(Retired) dismissed the postponement claims as unfounded and spurious. He assured that, contrary to social media rumors suggesting a delay due to a court order, preparations for the elections are proceeding as planned.

On Wednesday, the National Assembly Rerun Election Petition Tribunal in Bauchi upheld the election of Senator Pam Mwadkon Dachungyang of the Action Democratic Party (ADP) as the duly elected Senator representing Plateau North. The three-man tribunal panel, chaired by Justice Cordelia Ogadi, dismissed the petitions filed by Shafi'u Sahlan of the New Nigeria Peoples Party (NNPP) and Ambassador Chris Giwa of the All Progressives Congress (APC) due to lack of merit.



Upcoming Local Government Elections ¹




