Edo REC won't be removed, INEC tells PDP

The Independent National Electoral Commission (INEC) has dismissed calls from the Peoples Democratic Party (PDP) to remove the Resident Electoral Commissioner (REC) for Edo State, Anugbum Onuoha, ahead of the September 21, 2024 governorship election. Governor Godwin Obaseki and the PDP leadership raised concerns over Onuoha's ties to the Minister of the Federal Capital Territory, fearing potential bias in favor of the All Progressives Congress (APC).


Senate to amend constitution to ensure LG autonomy – Akpabio

Court gives Kwara electoral commission go ahead to conduct LG poll

A Federal High Court in Abuja has lifted an ex-parte order that barred the Independent National Electoral Commission (INEC) from releasing



the National Voter Register to the Kwara State Independent Electoral Commission (KWSIEC) for local government elections. Justice Peter Lifu vacated the order, initially issued on July 29, after ruling that it had expired under the law, having exceeded its 14-day limit. The decision came in response to a request by KWSIEC, with the court agreeing that the order should be set aside in accordance with legal provisions.



NSCDC deploys 3,000 personnel for LG polls in Kwara


