INEC releases polling, collation agent data for Ondo governorship election

The Independent National Electoral Commission (INEC) has released a summary of polling and collation agents submitted

by political parties for the 2024 Ondo State governorship election, following the closure of its submission portal. The portal, which opened on August 20, 2024, automatically closed at midnight on September 30, 2024, in accordance with the election timetable issued in September 2023. The upcoming election will take place across 3,933 polling units and 222 collation centers, including 203 ward centers, 18 Local Government centers, and the state collation center in Akure.

Electoral offences: Obey court judgment or face contempt charge, SERAP tells INEC chair

The Socio-Economic Rights and Accountability Project (SERAP) has called on Professor Mahmood Yakubu, Chairman of the Independent National Electoral Commission (INEC), to promptly enforce a court ruling that requires INEC to investigate bribery allegations against state governors and their deputies, as well as other electoral offenses from the 2023 general elections. July 18, 2024, followed a mandamus lawsuit filed by SERAP. In a letter dated September 28, 2024, SERAP's deputy director, Kolawole Oluwadare, emphasized that INEC must not take the judicial system lightly.

Yiaga Africa Charges KADSIECOM On Credible LG Polls, As Commission Returns To Manual Voting

On Thursday, Yiaga Africa paid a courtesy visit to the Kaduna State Independent Electoral Commission (KAD-SIECOM), where the commission announced it would not deploy electronic voting machines for the upcoming local government election on October 19, 2024. The commission was charged to uphold credible local government polls despite the decision to revert to manual voting.

LG Election: Cross River Government Succumbs to Demand for Lower Cost


Cross River State Governor

Fubara imposes two days holiday, strict movement restrictions for upcoming LG elections

Rivers State Governor Siminalayi Fubara has declared October 3 and 4, 2024, as public holidays to facilitate travel for residents ahead of the Local Government elections on Saturday, October 5. In a state-wide broadcast from Government House in Port Harcourt, he also imposed a strict ban on vehicular movement from midnight on October 4 until 5 p.m. on Election Day.


