Edo poll: INEC debunks BVAS smuggling allegations


The Independent National Electoral Commission (INEC) has dismissed allegations of smuggling BVAS machines in Edo State, calling the claims baseless and without merit. In a statement issued on Friday in Benin, the state's Resident Electoral Commissioner, Dr. Anugbum Onuoha, confirmed that the commission had completed its investigation and found no evidence to support the accusations.

INEC commits to flawless election in Ondo

The Independent National Electoral Commission (INEC) has committed to delivering a seamless election for the upcoming offcycle governorship poll in Ondo State on November 16. During a recent briefing, the state's Resident Electoral Commissioner, Oluwatoyin Babalola, assured residents of the commission's dedication to conducting a flawless electoral process, highlighting that potential challenges have already been identified. Babalola confirmed that non-sensitive materials have been distributed to all 18 local councils and that Registration Area Technical Support Staff (RATECH) will be assigned to each Registration Area to provide immediate technical assistance for the Bimodal Voter Accreditation System (BVAS) across the 3,933 polling units.

Rivers Police launch fullscale investigation into post-election violence

The Rivers State Police Command has launched a fullscale investigation into a deadly outbreak of violence across multiple local government areas

in Rivers State on Monday, which claimed lives and caused significant property damage. Commissioner of Police Mustapha Mohammed confirmed the probe on Wednesday after visiting the affected areas, stating that an investigation team, led by the Deputy Commissioner of Police, State Criminal Investigation Department, has been deployed.



Again, Court refuses to stop Kano LG elections

The Federal High Court in Kano has dismissed an application seeking to halt the local government elections set for October 26. The ex parte motion, filed by Engineer Muhammed Babayo, a factional member of the New Nigeria Peoples Party (NNPP),

sought an interim injunction to stop the electoral process. Babayo's legal team, led by Dalhatu Shehu Usman, had challenged the Independent National Electoral Commission (INEC), the Kano State Independent Electoral Commission (KANSIEC), the Inspector General of Police, and the Director General of the Department of Security Service.

Suspended Lagos LG chair sues Speaker, Assembly, says action affront on Supreme Court

Jelili Sulaimon, the Chairman of Alimosho Local Government Council, Lagos, has denounced his suspension by the State House of Assembly as illegal and unconstitutional. In a statement released by his lawyer, Abdul Mahmud, on Tuesday, Sulaimon condemned the suspension, calling it a direct violation of the Supreme Court's recent ruling that affirmed the autonomy and independence of local governments under the 1999 Constitution. The statement also criticized the decision of the House and Speaker Mudashiru Obasa to install Sulaimon's deputy as interim head of the council.


